with the territorial agencies for employment and have the right to be employed under the same conditions as Romanian citizens.



The National Agency for Employment, through its territorial structures, offers the following free services to Ukrainian citizens registered with the NAE:

- **vocational information and counselling** - services provided free of charge to jobseekers, aimed at providing information on the labour market and the evolution of occupations; profiling and assessing the employability level; training in job search methods and techniques and guidance during the process of socio-professional integration at the new workplace.
- **job-matching** - putting employers in contact with jobseekers with a view to establishing employment or service relations. Job-matching services are provided free of charge to persons registered in the NAE's database.
- **vocational training** - increasing and diversifying professional skills in order to ensure mobility and integration into the labour market, provided free of charge to persons registered in the NAE database. Access to vocational training programmes is provided following vocational information and counselling or job-matching.
- **assessment and recognition of professional competences obtained in non-formal and informal contexts** - for people who do not hold a certificate of professional competence, qualification or graduation for certain skills, occupation or qualification and do not have any medical restrictions. Access to free assessment and certification services for professional competences acquired through non-formal means is provided following vocational information and counselling or job-matching.
- **EURES support services** - information, advice and job-matching services for jobseekers in the EU and the EEA. These services are provided free of charge and consist of: provision of information on the European labour market; information on working and living conditions in the EU and EEA Member States; information on the European and national EURES portals; presentation of job vacancies at European level; information on mobility schemes and similar European assistance and/or financial support programmes.

Ukrainian citizens wishing to work in our country do not need a work permit for a period of 12 months, with the possibility of extension. They have to register

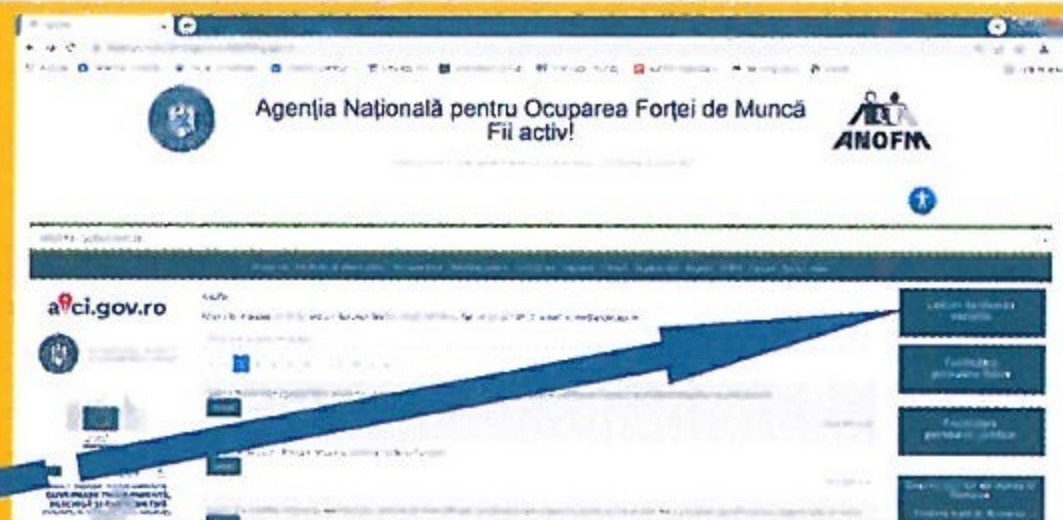
